## STATE OF TEXAS

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS, APPOINTING KEVIN KOLB TO SERVE AS PRESIDING JUDGE OF THE SEGUIN MUNICIPAL COURT OF RECORD, APPROVING AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT BETWEEN THE CITY OF SEGUIN AND JUDGE KOLB; PROVIDING FOR FINDINGS OF FACT AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, by Ordinance 2012-10, the Seguin City Council established a Municipal Court of Record beginning October 1, 2012; and

**WHEREAS**, the Seguin City Council appointed Kevin Kolb to serve as the Presiding Judge of the Seguin Municipal Court of Record for a two-year term that ends September 30, 2014; and,

**WHEREAS**, by this Resolution the City Council will reappoint Kevin Kolb to serve another two year term beginning October 1, 2014; and

**WHEREAS**, the parties wish to set forth the duties and responsibilities of each party; and,

WHEREAS, Kevin Kolb is deemed an independent contractor; and,

**WHEREAS**, the attached Agreement is effective October 1, 2014, through September 30, 2016, unless sooner terminated as provided by the terms of the Agreement, and includes the same terms and conditions as the previous agreement; and,

**WHEREAS**, the City Council of the City of Seguin, Texas, deems it in the public's interests to approve and authorize the execution of the Agreement between the City and Kevin Kolb

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Seguin, Texas:

**SECTION 1.** The findings and recitations set out in the preamble to this Resolution are found to be true and correct and they are adopted by the City Council and made a part hereof for all purposes.

**SECTION 2.** The Seguin City Council hereby appoints Kevin Kolb to serve a two-year term as the Presiding Judge of the Seguin Municipal Court of Record beginning October 1, 2014.

**SECTION 3.** The Seguin City Council approves and authorizes the City Manager, Douglas G. Faseler, to execute the Agreement between the City of Seguin and Kevin Kolb, as attached hereto as Exhibit A and incorporated herein for all intents and purposes.

**SECTION 4.** This Resolution shall be and become effective immediately.
