Mayor Donna Dodgen announced that AACOG MPO has a public input survey involving two important projects for Seguin. It is very important to take the survey to submit #49 and #2. Cordova Road is vital to Guadalupe County and the City of Seguin with all the new subdivisions developing and proposed along this two-lane road. The deadline for public input is through June 27, 2021.

City Manager Steve Parker updated the City Council on the COVID-19 at GRMC. Currently there are two patients at GRMC. We need to remember to take precautions to help reduce the spread of the virus.

City Manager Steve Parker introduced Adam Latern who is an Intern who will be working with us this summer. He is pursing a Master's Degree in Public Administration.

# 6. <u>Presentation</u>

a. 21-205 Drainage 101 Presentation - David Rabago, P.E., CFM, City Engineer

#### Indexes:

Stormwater 101 presented to City Council by Troy Dorman, P.E. with Halff & Associates. Stormwater runoff is rainwater that does not soak into the ground. A stormwater system manages the flow of stormwater during storm events to help prevent flooding. Runoff can pick up pollutants, sediment, and debris that are harmful to plants, animals, and humans. These pollutants can affect the river, streams, and waterways of the region.

A Stormwater Utility Fee is a monthly user fee designed to fund the implementation of best management practices, improvements to stormwater infrastructure, enhancements to water quality, and mitigation for future flooding events and their impacts. A Stormwater Utility Fee provides a dedicated revenue stream to address stormwater infrastructure projects and activities that mitigate stormwater impacts.

Objectives of the Stormwater Utility Fee

- \* Create a fair and equitable fee structure for stormwater, reflecting drainage or runoff generated by each land use (residential, commercial, agricultural, etc.
- \* Create a stable revenue system for drainage improvement projects, flood mitigation, and improved or improving water quality
- \* Maintenance and construction of channels, including open ditches, pipe systems, and streets, curb inlets and drainage structures, and other types of improvement
- \* Management of vegetation to ensure excessive growth does not impair stormwater runoff flow
- \* Infrastructure repair and replacement, including inspections and asset management

The Stormwater Utility Fee can be created by the Mayor and City Council pursuant to Municipal Drainage Utility Systems Act, found in Chapter 552 of the Texas Local Government Code. The Code does require a transparent equitable process that includes all stakeholders that will be impacted.

The Stormwater Utility Fee will continue to be assessed to the owner or occupant of the "benefited property," which includes any lot or parcel or real property, which contributes runoff into the City's stormwater system.

1) It will be used to protect the waterways by removing and reducing pollutants which enter the storm drainage system and watershed. 2) It will fund projects to remove localized ponding of runoff, drainage improvement projects, and maintenance of systems to improve drainage in all areas of the city. 3) It will fund upgrades to older systems that ensure resident safety throughout the city. 4) It funds maintenance of all publicly owned drainage systems that ensures the drainage system is operating at its peak when a flooding event occurs. 5) It provides a stable revenue fund that allows the City to apply for grant funds requiring a local match.

Current City funding tied to essential services with almost 50 percent of the city budget dedicated to public safety (police & fire). Seguin is facing rapid growth from residential, multi-family, commercial, and industrial development. The Stormwater Utility Fee will

help the city have a dedicated revenue system to address the growth and the impact it has on our local drainage infrastructure and address Seguin's costs related to control and treatment of stormwater including flooding issues and water quality.

Needs assessment for a capital plan, early communication of project, building fees, determine the rate for all Seguin customers. Currently using the Appraisal Districts data to help City Council set a rate. Texas Local Government Code, Chapter 552: Establishes utility for a minimum of 5 years; Separate enterprise fund; Dedicated to drainage-related needs; Establishes fee based on a drainage-related parameter; and Calls for public hearings and ordinance adoption.

Public Hearing scheduled for July 8, 2021 and early August, and then possible adopt an ordinance.

Live survey will be on-line for about 4 months for the general public.

Walnut Branch Drainage Improvements 1) Pond expansion south of IH-10; 2) Pond expansion north of IH-10

Walnut Branch Drainage Improvements 3) Drop inlet with storm drain under Aldama Street to channel; 4) 90 foot span bridge on San Antonio Avenue; 130 foot span bridge from Jones Street across the springs
