**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS, EXPRESSING SUPPORT FOR TEXAS SENATE BILL 1074 AND TEXAS HOUSE BILL 2876, WHICH WOULD ALLOW TXDOT TO AMEND ITS EXISTING AGREEMENT FOR A PORTION OF STATE HIGHWAY 130 AND ADVANCE FUNDING FOR NON-TOLLED TRANSPORTATION PROJECTS BETWEEN INTERSTATE 35 AND STATE HIGHWAY 130.**

**WHEREAS**, Seguin, Texas is experiencing rapid population growth and commercial development; and

**WHEREAS**, the City of Seguin supports transportation and forward-thinking solutions to manage this growth; and

**WHEREAS**, Texas State Highway 130 (“SH 130”) is an important transportation route for the City of Seguin, the San Antonio-Austin Corridor, and the State of Texas,

**WHEREAS**, Additional infrastructure investment is needed to service the continued growth in the City of Seguin, the San Antonio-Austin Corridor, and the State of Texas,

**WHEREAS**, such projects must be developed in collaboration and partnership with our neighboring communities, city and county officials, TXDOT, the Alamo Area MPO, and other community stakeholders; and

**WHEREAS**, the Texas Legislature is currently convened in its 89th Legislative Session; and

**WHEREAS**, SB 1074 and HB 2876 have been introduced at the Texas Legislature to fund the development of non-tolled transportation projects through amending the State’s existing agreement with SH 130; and

**WHEREAS**, this legislation is supported by the San Antonio Mobility Coalition, Greater:SATX, and numerous other local and regional organizations.

**NOW, THEREFORE, BE IT RESOLVED**, that the City of Seguin hereby adopts this Resolution supporting the passage of SB 1074 and HB 2876 to advance investment in non-tolled transportation projects that are supported by the region.

**BE IT FURTHER RESOLVED**, that the City of Seguin encourages all members to support this important legislation and work to ensure its swift passage into law.

**BE IT FURTHER RESOLVED**, that the City of Seguin urges all relevant house and senate committees to take all necessary steps to review this legislation in a timely and effective manner.

**BE IT FINALLY RESOLVED**, that a copy of this resolution be transmitted to Representative Alan Schoolcraft, Senator Judith Zaffirini, Senator Donna Campbell, Senator Roland Gutierrez, and other appropriate government officials, as well as to other interested individuals and organizations.
