Nivia Maldonado, 4573 Prairie Summit, said that she lives in the unincorporated part of Seguin and does not receive household hazardous waste disposal service in her area. She would like that service to be offered and asked if and when that would be possible.

Councilmember Rangel thanked Waste Connections, LLC and Texas Lutheran University for support of the bi-annual clean-up this weekend. He reported that the event went really well and thanked all of the volunteers who helped make the event

successful.

Mayor Dodgen announced that it was Deputy City Secretary Kim Allison and Police Chief Jason Brady's birthday and wished them both a Happy Birthday. Additionally, she reported that the first Citizens Police Academy class was tonight and that the Police Department has 1 cadet graduating from the Alamo Area Council of Governments Police Academy. Also, she invited everyone to attend the second public input meeting related to the redevelopment of the downtown Wells Fargo building. The meeting will be held on Thursday, March 7, 2024 at 6:00 P.M. at the Seguin Public Library. Lastly, she announced that the Park West Splash Pad will open this Friday, March 8th.
