Finance Director Susan Caddell offered to answer any questions City Council has related to the proposed budgets for Fiscal Year 2024-2025.

City Manager Steve Parker declared that he was proud of way the proposed budgets address the needs of our growing community, including recreational amenities, and reiterated that the 2.5% step increase and the 3% Cost of Living Adjustment will be provided to City of Seguin employees.

Mrs. Caddell reminded that the staff is recommending adoption of the same tax rate as last year and that the Public Hearings for the budgets and tax rate will be held at the September 3, 2024 City Council meeting.

Tim Howe introduced Vice President of Willdan Financial Services Dan Jackson, a consultant who worked with City Staff to help determine water and wastewater rates for this year and subsequent years. The City has been working with Mr. Jackson since the initial water and wastewater study in 2015. Mr. Howe thanked Mayor Pro Tem Carter, Councilmember Keller, and Councilmember Rea for their participation on the Utility Rate Committee. He announced that it was determined that a five percent increase in rates is recommended and asked Mr. Jackson to present the details of the recommendation.

Mr. Jackson said that he has been a rate consultant for the City of Seguin for the last decade and that Seguin is in good shape as it has the ability to meet the water and wastewater demands of the future. Each year, he provides the City with a recommended rate for the next budget year as well as forecasts future rates. Factors that impact the rate plan are growth in the number of accounts, Capital Improvement Project cost increases, existing and future debt costs, and impact fee revenue.

Mr. Jackson stated that because Schertz Seguin Local Government Corporation announced no rate increase for the next three years and operating costs have been accurate and controlled, the 2022 rate plan is still accurate. He added that the City has entered into contracts with large commercial entities that are buying significant amounts of water and that has helped the City to stay on plan.

Councilmember Lievens asked with the doubling of the number of City's water accounts, the growth on Rudeloff, and the transfer area of Spring Hills CC&N if the rate of growth should be reflected even more significantly. Mr. Howe the existing customers in the Spring Hill transfer area, approximately 2,500 customers, will be added to the system immediately around the first quarter of 2026 once all the infrastructure is in the ground. Additionally, the rest of the transfer area is ripe for development once the water is accessible there.

Mr. Jackson declared that this is a very dynamic situation that needs to be reviewed annually. If growth is even more robust than projected, it will minimize the need for future rate increases. The growth of revenue and expenditures is not a one-to-one relationship and more growth is better. He informed that the City's primary challenge is the capital improvement projects and the approximate \$364M in bonds to be issued for replacement, repair, and expansion of the system. The good news is that the current rate plan is able to absorb the additional debt service. While the total cost of service will increase by 50-60%, the amount of customers will double. The growth is paying for itself.

Mr. Jackson restated that the recommendation is to continue to implement the 2022 rate plan -- a 5% rate adjustment for water and wastewater, to be effective October 2024. He projects that after 2027 the magnitude of rate adjustments will fall. The biggest concern that could affect forecasted rates is raising interest rates. Currently, projections are 5% adjustments for 2025 and 2026, and 3% adjustments for subsequent years.

This years proposed rate adjustment of 5% would affect the average residential customer by about \$5.24 a month. This adjustment is right in line with the average for state and federal rate adjustments.

Mr. Howe declared that the City Staff analyzes the capital improvement projects and rate projections each and every year to be sure that the City is making the best possible decision for the future of the water and wastewater system.

Councilmember Biesenbach asked Mr. Howe to expound on why the new Geronimo Creek Wastewater Treatment Plant has to built and the regulation that requires the City to build it. Mr. Howe explained that TCEQ's 75/25 Rule requires a city to initiate design of a new wastewater treatment facility when their current facility reaches 75% capacity. Additionally, a city must be under construction of a new wastewater treatment facility when their current system reaches 90% capacity. He reminded that when City Council decided to decommission the Walnut Branch treatment plant, it was decided that future CIP monies would not be put into Walnut Branch, but that those monies would be used to combine and build one bigger wastewater treatment plant.

Mayor Dodgen said that Seguin is an ageing city with ageing infrastructure and that wastewater systems aren't sexy, but are needed.

City Manager Steve Parker explained that it is difficult to compare apples to apples with surrounding cities, but when compared equally to surrounding cities, Seguin offers on the lower end of rates for all three utilities. Mr. Jackson added that most utilities do not cover their own costs, the City of Seguin's independent utilities all pay for themselves and balance the need of reasonable rates with meeting the needs of its customers.

Mr. Howe added that Seguin is fortunate as it has the water supply to meet its needs to 2080.

Deputy City Manager Rick Cortes said that similarly to the water/wastewater study, the City does an electric rate study each year and every 5 years the City does an in depth study of the cost of service. He introduced Ramsey Cripe with Schneider Engineering to present the results of the electric rate study. Mr. Cripes informed that Seguin's rates are significantly lower than neighboring electric utilities. The Electric Utility has a net positive position, collecting \$33M in revenue and expending \$31.5M, resulting in about a 4.9% recovery rate.

He reminded that there have been very minimal rate changes since the initial adjustment in 2013. This year, a \$1 increase to the fixed charge for residential customers, from \$14.50 to \$15.50. Small commercial rates will remain unchanged and some offsetting cost changes that include an increase in demand charge and a

reduction in energy charge for large commercial and industrial users.

Parks and Recreation Director Jack Jones stated the proposed rate changes are the recommendations of the Parks and Recreation Commission. He explained that the proposed rate changes include;

- 1. the implementation of a \$10 cancellation fee for Summer Day Camp;
- 2. increasing the wave pool private party fee from \$525 to \$600;
- 3. amending the rental fee structure of the Seguin Coliseum from a 3-tier fee system to a flat rate system that does not depend on attendance of the event but instead on which day the facility is being rented;
- 4. increasing the daily Rodeo Arena fee from \$250 on week days and \$400 on weekends to a daily rental fee of \$500; and
- 5. removing and deleting several items from the fee schedule that are no longer applicable.

Parks and Recreation Director Jack Jones declared that Phase 2 of the Seguin-Saegert Pickleball Complex has been long awaited. This phase includes demo/dirt work, construction of a restroom, sidewalk, and a shade structure on the west side of the pickleball courts. The City received a Choice Partners quote from Sullivan Contracting Services in the amount of \$162,106.97 to do the demolition, excavation, plumbing, electrical, fencing, grading, and general site cleanup work needed. Choice Partners is a Local Government Purchasing Cooperative and is in compliance with all State bidding requirements.

Economic Development Director Josh Schneuker reminded that Tyson Foods Inc. announced the expansion of their Seguin facility in late 2021. That project, which resulted in capital investment exceeding \$58M and the creation of at least 40 new jobs, has been completed. Mr. Schneuker explained that a key aspect of the expansion was the relocation of Tyson's truck access point from Kingsbury Street to Lawson Street to manage the increased truck traffic and enhance pedestrian safety. To support this change, the City planned the Lawson Street Reconstruction Project, which involved reconstructing and expanding Lawson Street from Kingsbury Street to C.H. Matthies Drive. Mr. Schneuker stated that the project consists of approximately 1,091 feet of new concrete.

Mr. Schneuker informed that the City released a Request for Qualifications in July of 2024 and that the City received four responses. After reviews by City Staff and Freese and Nichols, E-Z Bel Construction, ILC is recommended for the contract award in an amount not to exceed \$1,916,973.74. He declared that the cost of the project is 13% below projected costs and that the City was able to secure a \$1M grant through the Texas Department of Agriculture's Texas Rural Business Fund.

Mr. Schneuker thanked the Director of Capital Projects and Engineering Melissa Reynolds, Project Manager Michael Sharp, and Real Estate Manager Connie Real for their assistance on this project.
