Josh Cortez, announced that he is running for the Texas 35th Congressional District. He said he was raised in Zorn, Texas and attended New Braunfels Christian Academy for High School. He declared that, if elected, he will work to resolve the water crisis effecting Guadalupe, Wilson, and Karnes County as well as encourage students to attend trade and technical school, and help to ensure that rural firefighters get the equipment they need though the SAFER grant.

Library Director Silvia Christy announced that the Seguin Public Library has launched its annual food drive, "Neighbors Helping Neighbors" that will collect from November 1, 2025 through December 31, 2025.

Chief of Police Jason Brady stated that the Seguin Police Department has administered the Blue Santa Program for the last twenty years, which would not be possible without the generosity of community. They received nearly 400 applications in 2022. Due to unprecedented growth, new measures are being taken to prioritize for those most in need of assistance. They will partner with local school districts to help select families that will receive support. Families who homeschool their children are also eligible to apply by reaching out to the Community Engagement Officer.

Parks and Recreation Director Jack Jones informed that the new playground at Manuel C. Castilla Park is almost finished and is planned to open by the Thanksgiving holiday.

The new playground is 7 or 8 times larger than the old playground. He also informed that the four fitness stations are already open. He also showed pictures of the practice field and how it is more grassy and green than it was last year. Lastly, he informed that they are planning to irrigate inside of the track.

Councilmember John Carlsson announced that the Village of Mill Creek HOA meeting is tomorrow at 6 P.M. He also thanked the Director of Public Works and the Director of Engineering and Capital Projects for conversing with him this week about the roads in his neighborhood. He stated that the roads in his neighborhood are in sad shape and suggested that the City get the capability to do asphalt density tests. He said he understood that those transitioning from Spring Hill Water to Seguin will have their Spring Hill deposits credited to their Seguin utility accounts and would not have to provide another deposit. Additionally, he said that he is greatful for all the road work done on Rudeloff Road but now it has turned into Texas Motor Speedway. Lastly, he announced that November 10th is the 250th birthday of the United States Marine Corps.

Councilmember Jason Biesenbach invited everyone to attend the 2nd Annual Lights and Siren Cornhole Tournament hosted by the Seguin Police & Fire Citizens Academy Alumni Associations on Saturday, November 15th. The event will include food trucks, raffle items, silent auction items, and snacks and music.

Councilmember Jim Lievens thanked Councilmember Carlsson for talking about Rudeloff road. He stated that the Police Department has done an excellent job patrolling for thru truck traffic cutting through Mill Creek Crossing. He invited everyone to attend the First Friday Feast this Friday, which will benefit the Christian Cupboard. He also invited everyone to attend the Golden Shovel Tree Planting Ceremony on Thursday at Park West at 10:30 A.M. and commented that he would like to see more trees planted at other parks.

Mayor Donna Dodgen announced that the Art & Wine Walk is this Saturday, November 8th from 3:30 to 6:30 P.M. where attendees can sip, stroll, and savor local art throughout downtown Seguin. Tickets are available the day of event at a booth in Central Park and at several downtown retailers. She also informed that the Community Table Annual Thanksgiving Meal is Sunday, November 23rd at the Seguin Coliseum from 4-6 P.M. This is a free meal for anyone in the community. Lastly, she announced that she will be moving item 9a and 10a to the top of the agenda so that those who need to leave for the volleyball game can do so.

Economic Development Director Josh Schneuker reminded that City Council established TIRZ #3 in October 2025. Included in this ordinance was the establishment of a Board of Directors, made up of the members of the Seguin City Council and representatives from any additional participating entities, with the Mayor serving as board Chair. This Board would act as recommending body for all TIRZ #3 administration activities to the City Council, who will retain ultimate authority to vote on Board considerations.

One of the key requirements in the creation of a tax increment reinvestment zone is that a Project and Financing Plan be approved. This plan identifies specific improvements that the TIRZ fund anticipates supporting, while also providing certain details on how these improvements will be paid for. Included within the creation Ordinance for TIRZ #3, (Ordinance No. 2025-058), was a preliminary Project and Financing Plan, which has now subsequently become the Project and Financing Plan up for consideration before the TIRZ #3 Board of Directors today.

Mr. Schneuker informed that if the TIRZ #3 Board of Directors choose to approve the Resolution authorizing and accepting the presented Project and Financing Plan for the Zone, a subsequent recommendation to City Council will follow to legally authorize the same Plan via Ordinance. He invited David Pettit, with Pettit and Ayala Consulting, to explain the Project and Financing Plan.

6. Presentation

a. <u>25-624</u> Guadalupe Regional Medical Center FY2026 Budget. - Robert Haynes, CEO

Robert Haynes, CEO of Guadalupe Regional Medical Center, introduced his staff and board members who also were attending the meeting. He declared that this is GRMC's 60th year and he is proud of the work they are doing. He informed that GRMC employees between 950-1,000 people and their payroll budget is \$75M. Over the years, that have been able to provide \$150M in prescription assistance and perform over 10,000 surgeries, 75,000 imaging procedures, 34,000 ER visits, and deliver 600 babies each year. He also informed that GRMC has 150 physicians on staff. He stated that GRMC participates in the Modern Healtcare periodical and this year they ranked #8 total and in facilities their size, they ranked as the #1 place to work.

Cody Gann, Guadalupe Regional Medical Center Chief Financial Officer, gave an overview of their proposed FY2026 budget, highlighting a estimated net income of \$10.8M for FY26.

Councilmember Carlsson commented that he read that there was a 2% cost-of-living adjustment budgeted for employees and questioned if there was a performance-based pay increase offered as well. Mr. Gann explained that there is a 2% cost-of-living adjustment for all employees. Then, specific department pay increases are addressed as needed. Mr. Carlsson also asked Mr. Gann to explain what the bad debt expense was and Mr. Gann informed that it is the hospital writing off the patient debt that is unable to be collected after GRMC has made attempts to collect it.

b. 25-621

Presentation on Reforestation Areas and Grow Zones. - Melissa Reynolds, Director of Engineering & Capital Projects, and Jack Jones, Director of Parks & Recreation

Director of Engineering and Capital Projects Melissa Reynolds and Parks and Recreation Director Jack Jones gave a presentation on Reforestation Areas and Grow Zones, informing that some maintenance practices in Walnut Springs Park, along the trail behind the Seguin Public Library, and other areas of town will need to be changed to allow for the creation of natural habitats and to meet the requirements set by the Army Corps of Engineers due to the loss of natural habitats over the span of many years and many construction projects. Some of the changes will include that there will be that they are not able to mow along the creek bed, except for 5' from the edge of the trail. They are able to trim vegetation, but no shorter than 18". They informed that they are working to create no mow zones and signage that explains why it cannot be mowed. Mr. Jones said that the areas that the public will notice quickly will be behind the library as well as some of the disc golf holes that will be affected. He said his department will make adjustments to the disc golf course and cross country meet routes to accommodate the required changes.

Mayor Dodgen suggested that alerting the schools of the change is a good start and that the Public Information Office is working on a video and updating the City's website. She said the City is going to need to do other educational type things to help spread the word.

Councilmember Biesenbach asked if Egrets are protected and Mrs. Reynolds confirmed that they are protected.

Mayor Dodgen asked if the Army Corps of Engineers will come back and reevaluate and Mrs. Reynolds informed that they will do an annual walk and annual meeting with her department to confirm compliance.

Mr. Jones stated that he apprised the Parks and Recreation Commission of the changes at their last meeting.

Councilmember Lievens questioned if the requirements are primarily related to grasses or is it requiring the City to plant more trees. Mrs. Reynolds said that the City is required to replace the trees that were lost as a result of the projects, not those that died naturally.

Mrs. Reynolds also commented that this change in practice might bring in opportunities to work with Master Naturalist and Master Gardeners in the area, to help reclaim vegetative areas with native, less invasive, plants.

c. 25-635

Update on Starcke Park Golf Course renovation and anticipated opening date. - Bruce Allen, Golf Course Manager

Golf Operations Manager Bruce Allen showed a video of the current condition of Starcke Park Golf Course. He informed that the golf course, due to rain delays, change order delays, permitting delays, and unforeseen problem delays, the Golf Course's anticipated opening date will be late spring or early summer 2026.

Councilmember Carlsson asked if he received all the equipment that was authorized and Mr. Allen confirmed he received it all two weeks ago. Councilmember Carlsson asked if there were any overages and Finance Director Susan Caddell confirmed that there is still fund balance available.

Mayor Dodgen thanked Mr. Allen for everything and for keeping Golf Course Advisory Committee apprised of the changes. She stated that it is imperative that the golf course is done correctly and right, so she understands that we need to be patient.

8. Action Items - Discussion and Possible Motion to Approve

a. 25-620 Resolution awarding an annual contract for the purchase of advanced metering infrastructure and compound water meters in various sizes to Core and Main; and declaring an effective date. - Timothy J. Howe,

Director of Utilities

Utilities Director Tim Howe stated that the City must install new water meters annual. This resolution would award an annual contract for the purchase of water meters in various sizes. The City received 6 bids ranging from \$779,264.00 to \$2,732,706.50. City Staff recommends awarding the contract in the amount of \$981,276.00 to Core and Main of Kyle, Texas. Core and Main was not the lowest bid, but the lowest qualified bid. The contract proposal includes options for four annual renewals. Funding for this purchase will come from the Utility Fund Water Inventory account.

Councilmember Lievens asked if residents pay fees for new meters and Mr. Howe responded that it is covered within the Utility Budget and there is not an extra fee passed on to residents for meters. Councilmember Lievens also asked if the neighborhoods getting their meters swapped out due to the Spring Hills transfer have been made aware. Mr. Howe explained that they have received welcome letters detailing that they need to create a City of Seguin account if they do not already have one, but the letter did not mention the meter swapping.

Resolution approving an amendment for engineering services related to the 12-inch wastewater main replacement and 8-inch water main extension project; and declaring an effective date. - Terri Lynn Ruckstuhl, Senior Utilities Engineer.

Senior Utilities Engineer Terri Ruckstahl reminded that the City Council had approved an engineering services proposal for the design and construction phase services of a 12-inch sanitary sewer replacement and an 8-inch water main extension project to increase capacity in the wastewater collection system from the Cordova Lift Station to Link Road. In addition, the proposal included the design of an 8-inch water main extension from the Navarro High School property north along State Highway 123 to Link Road continuing west. Mrs. Ruckstahl informed that WGA provided the City's Utilities Department with an amendment proposal in the amount of \$309,829.00 for an extension of approximately 6,300 LF of the upsized 12-inch water main, an additional 3,800 LF of 8-inch water main, and appurtenances. She explained that the amendment was necessary to expand service into the CC&N service area and eliminate existing dead end mains. Funding for this project has been secured through certificates of obligation.

Resolution approving a change order for the installation of 14-inch sewer force main related to the Geronimo Creek WWTP Expansion Project; and declaring an effective date. - Terri Lynn Ruckstuhl, Senior Utilities Engineer.

Mrs. Ruckstahl stated that PLW Waterworks, LLC provided the City's Utilities Department with a proposal in the amount of \$996,309.62 for the installation of approximately 1,432 LF the 14-inch sewer force main at the Geronimo Creek WWTP. This project will provide necessary capacity to decommission the existing Gateshead lift station and serve neighboring tracts of land east and west of FM 466 in the area around the subdivision known as the Meadows of Nolte Farms. Funding for this project has been secured through certificates of obligation and City Staff recommends the change order be approved for \$996,309.62, plus \$53,690.38 in contingencies, for a total of \$1,050,000.00. TRC Engineers reviewed the proposal and found that PLW Waterworks, LLC provided consistent pricing in the current market.

Resolution awarding the bid for the construction of the FM 20 / Hannah Heights Water Line Project to M&C Fonseca Construction Co. Inc.; and declaring an effective date. - Terri Lynn Ruckstuhl, Senior Utilities

Engineer.

Mrs. Ruckstahl explained that this resolution would authorize the award of a construction contract to install approximately 4,000 LF og 12" PVC water main with all other necessary appurtenances. This project is prescribed as part of the 2022 Water Master Plan and is designed to improve service to the existing developments as well as provide adequate capacity for the parcels immediately south and east. The scope of work included both engineering design and construction administration. Mrs. Ruckstahl stated that the City received 7 sealed bids and it is recommended that M&C Fonseca Construction Co. Inc. be awarded a construction contract for \$908,389.10, plus \$91,610.90 in contingencies, for a total amount of \$1,000,000.00. Lochner conducted reference checks and found that M&C Fonseca Construction Co. Inc. has completed similar projects to the satisfaction of the Owners and Engineers. The construction timeline for this project is 180 consecutive calendar days and funding for this project has been secured through certificates of obligation.

Councilmember Biesenbach stated that the number of feet needed was shortened from what was originally requested and Mr. Ruckstahl explained that after reviewing the design, they were able to reduce the amount needed and accomplish the same goal.

Resolution approving a Chapter 380 Agreement between the City of Seguin, Texas and Curt Manufacturing, LLC, authorizing the City Manager to execute the Chapter 380 Agreement, and declaring an effective date. - Josh Schneuker, Director of Economic Development

Director of Economic Development Josh Schneuker declared that today is a good day in Seguin. He informed that this resolution would approve a Chapter 380 Agreement with Curt Manufacturing, LLC, through its wholly owned subsidiary, Lippert Components, Inc, which is the parent company of Ranch Hand. Curt intends to utilize the facility for the production of aftermarket automotive parts to supply its customers throughout the United States. The project represents a total anticipated capital investment of approximately \$80 million, which includes an estimated \$60 million investment by the Developer in site and building improvements, and a minimum \$20 million investment by Curt in fixtures, machinery, and equipment.

Under the terms of the Chapter 380 Economic Development Agreement ("Agreement"), Curt has committed to creating and maintaining a minimum of 320 full-time equivalent employees with a total annualized payroll of at least \$20 million by December 31, 2029. The Agreement also requires Curt to obtain a Certificate of Occupancy no later than December 31, 2026, and to achieve its job creation and payroll benchmarks according to the schedule established in Article IV of the Agreement.

In return for these commitments, the City will provide Curt with a 10-year property tax

rebate incentive with a total value not to exceed \$2,500,000. Incentive payments will be calculated as a percentage of property taxes paid on real and personal property improvements associated with the Project and will decline over the term of the Agreement according to the following schedule:

- Years 1-2: 80% rebate
- Years 3–4: 75% rebate
- · Year 5: 50% rebate
- Year 6: 40% rebate
- · Year 7: 30% rebate
- Year 8: 20% rebate
- Years 9–10: 10% rebate

All payments are performance-based and contingent upon Curt's continued compliance with the investment, job creation, and payroll thresholds outlined in the Agreement.

Brian Schudiske, Vice President of Operations, stated that he is excited to make the move to Seguin and is looking forward to it being the home of Ranch Hand. He said that working with Economic Development Director Josh Schneuker made this decision an easy one for them.

Mayor Dodgen welcomed Mr. Schudiske and Ranch Hand to Seguin.
