

CITY OF SEGUIN

AN ORDINANCE OF THE SEGUIN CITY COUNCIL AMENDING THE SEGUIN CODE OF ORDINANCES ARTICLE III, BOARDS, COMMITTEES, COMMISSIONS, OF CHAPTER 2, ADMINISTRATION, TO PROVIDE A UNIFORM TERM OF OFFICE FOR ALL CITY BOARDS AND COMMISSIONS; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR AN EFFECTIVE DATE; AND AUTHORIZING CITY STAFF TO PREPARE THIS ORDINANCE FOR SUBMISSION AS A SUPPLEMENT TO THE CODE OF ORDINANCES

WHEREAS, the various city appointed boards and commissions have terms of office that expire on either September 30 or December 31; and

WHEREAS, the existing code governing boards does not reflect the current city operations; and

WHEREAS, having a uniform term of office for all of the boards and commissions expire at the end of the calendar rather than fiscal year is more manageable for City staff.

NOW THEREFORE BE IT ORDAINED by the City Council of the City of Seguin, Texas:

SECTION ONE. The Seguin Code of Ordinances, Chapter 2, Administration, Article III, Boards, Committees, Commissions, Section 46, terms of office, is amended as follows (underlining indicates added text, ~~striketrough~~ indicates deleted text):

(a) The terms of ~~the following~~ all of the City boards, ~~authorities~~ committees and commissions shall expire on ~~September 30~~ December 31:

~~(1) Building and standards commission.~~

~~(2) Examining and supervising board of electrical contractors and electricians.~~

~~(3) Housing authority.~~

~~(4) Parks and recreation advisory board.~~

~~(5) Plumbing appeals advisory board.~~

~~(6) Planning and zoning commission.~~

(b) The city manager shall notify the mayor no later than ~~August~~ November 1 of each year of appointments to the boards, ~~authorities~~ committees and commissions that will expire on ~~September 30~~ December 31.

SECTION TWO. All appointments that expire September 30, 2015, shall hold over until December 31, 2015, when new appointments pursuant to this Ordinance are made.

SECTION THREE. If any word, phrase, clause, sentence, or paragraph of this ordinance is held to be unconstitutional or invalid by a court of competent jurisdiction, the other provisions of this ordinance will continue in force if they can be given effect without the invalid portion.

**SECTION FOUR.** All ordinances and resolution or parts of ordinances or resolutions in conflict with this ordinance are repealed.

**SECTION FIVE.** City staff is authorized to prepare this Ordinance for submission as a supplement to the Seguin Code of Ordinances.

**SECTION SIX.** This ordinance shall be effective upon ten (10) days following passage on second reading.

**PASSED AND APPROVED** on second reading on the 6<sup>th</sup> day of October, 2015.
