The City Council met in a REGULAR Called Meeting on Tuesday, November 16, 2021 at 5:00 pm in the City Hall Council Chambers, City Hall, 210 East Gonzales in City of Seguin, with Mayor Donna Dodgen presiding.

Director of Finance Susan Caddell said that for the first time the City of Seguin has received a monthly sales tax allocation for over \$1,000,000! The month of September we received \$1,045,014, which is an increase of 29.56%. We finished FY21 at \$9,745,589, which is 13.14% above last year. You can see that this is a regional trend, with the majority of the cities around us up quite a bit.

City Manager Steve Parker provided a COVID update: GRMC has 3 cases. Also, Police Officer's Dustin Kincade and Sarah Wilson were featured on the Kelly Clarkson daytime talk show for helping a Seguin resident with donations of food and a refrigerator. In turn, Clarkson aided the department's cause with a \$1,000 donation to the woman.

Mayor Donna Dodgen reminded all that this is "No Shave November for Police & Fire" and this year they are taking donations for a Navarro student who is battling cancer. You may want to go on-line and vote for the best mustache in either department or make a donation through the Go Fund Me page..

Indexes:

Cindy Metro with Langford Community Management Services said the purpose of Section 3 of the Housing and Urban Development Act of 1968 is to ensure that employment and other economic opportunities generated by HUD financial assistance/grants, shall provide opportunities to low-and very low-income persons. As part of recent federal guidance changes, we are required to provide outreach and education in our community to satisfy this legal requirement. The City of Seguin's Texas Department of Agriculture, Main Street Program that is providing funds for the downtown sidewalk improvements has triggered this requirement. Given our grant portfolio, the City will most likely require an annual presentation regarding Section 3 as we move forward.

- b. [21-416](#) Juan Seguin Burial Site Signage - Jack Jones, Director of Parks and Recreation and Kyle Kramm, Main Street & CVB Director

Indexes:

Jack Jones, Director of Parks & Recreation, advised that in 2017 the Seguin Area Chamber of Commerce Leadership Class chose to create an ADA parking lot and ADA access to the Juan Seguin Burial site located off of South Saunders St. After meeting with city staff it was decided by the Leadership Class to create an ADA parking lot south of the fenced burial site and create a large informational sign so that visitors to the burial site can read and understand the history of Juan Seguin. The parking lot was completed in 2018 and work on the informational sign started but was never finished due to the class graduating. In 2020, city staff began working with Kendy Gravett, former Chamber President, to help design the sign and get it completed. The informational sign is 36" tall and 96" long and the sponsor sign is 24" tall and 36" long. Staff has received a quote for the signage to be completed and shipped for \$4,437.89. Available donated funding to pay for the two signs is \$4,593.52 from the Leadership Class and City Juan Seguin Burial Site donations account.
