## STATE OF TEXAS

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS INCREASING THE EFFECTIVE WASTEWATER CAPITAL RECOVERY FEES TO BE CHARGED; PROVIDING OF PUBLICATION OF THIS ORDINANCE; AND ESTABLISHING AN EFFECTIVE DATE

**WHEREAS**, in accordance with Texas Local Government Code Chapter 395, the City Council has approved changes to the City's land use assumptions, and capital improvement plans; and

**WHEREAS**, in order to fund future growth and the future utility needs for the City, the City Council has reviewed the adopted impact fee study and considered whether an updated maximum capital recovery fee ("Impact Fee") per living unit equivalent of proposed development should be assessed; and

**WHEREAS**, the discussion and testimony taken during the public hearing on changes to the City's land use assumption and capital improvement plans has also been considered in establishing both the maximum and effective Impact Fees; and

**WHEREAS**, Chapter 102, Article IX also provides for an effective Impact Fee per living unit equivalent that will be collected from persons obtaining building permits for new structures; and

**WHEREAS**, the water Impact Fee set in this Ordinance is separate from, and in addition to, any impact fee assessed by and through the Schertz-Seguin Local Government Corporation.

**WHEREAS**, in January 2021, the City Council established a maximum Capital Recovery Fee per living unit equivalent for water at \$1,132.00 and for Wastewater at \$7,757.00; and

**WHEREAS**, at the time the maximum fees were established, City Council approved an effective capital recover fees that were lower than the maximum allowable fee.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Seguin, Texas:

**SECTION ONE.** The City Council hereby approves the setting of the following as the Effective Capital Recovery Fee to be appropriately charged:

City Water \$1,132.00 per living unit equivalent

Wastewater \$7,139.00 per living unit equivalent

**SECTION TWO.** The new Effective Capital Recovery Fees shall be added to the list of Impact Fees kept by the City's Planning Department along with a copy of said list available through the City Secretary.

SECTION THREE. This ordinance shall be effective upon ten (10) days after publication of this
Ordinance and following passage on second reading.
