FIELDNOTE DESCRIPTION 0.048 ACRES AERIAL EASEMENT

BEING A 0.048 ACRE TRACT OF LAND OUT OF THE H. BRANCH SURVEY, ABSTRACT 6, LOCATED IN THE CITY OF SEGUIN, GUADALUPE COUNTY, TEXAS, BEING A PORTION OF THAT CERTAIN 14.918 ACRE TRACT CONVEYED TO ARVINDBHAI A. PATEL AND DHRUTI PATEL BY DEED OF RECORD IN VOLUME 2957, PAGE 431 OF THE OFFICIAL PUBLIC RECORDS OF GUADALUPE COUNTY, TEXAS, SAID 0.048 ACRE TRACT BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

COMMENCING, AT A FOUND TXDOT MONUMENT TYPE 1 AT THE INTERSECTION OF THE SOUTHWESTERLY RIGHT-OF-WAY LINE OF STATE HIGHWAY 123 (220' R.O.W.) AND THE EASTERLY RIGHT-OF-WAY LINE OF N. HEIDEKE STREET (R.O.W. VARIES), BEING THE NORTHWESTERLY CORNER OF SAID 14.918 ACRE TRACT;

THENCE, N 85° 04' 40" E, ALONG THE SOUTHWESTERLY RIGHT-OF-WAY LINE OF STATE HIGHWAY 123, BEING A PORTION OF THE NORTHERLY LINE OF SAID 14.918 ACRE TRACT, A DISTANCE OF 16.99 FEET TO THE POINT OF BEGINNING, AND THE NORTHWESTERLY CORNER HEREOF;

THENCE, N 85° 04' 40" E, CONTINUING ALONG THE SOUTHWESTERLY RIGHT-OF-WAY LINE OF STATE HIGHWAY 123, A DISTANCE OF 11.48 FEET TO THE NORTHEASTERLY CORNER HEREOF;

THENCE, LEAVING THE SOUTHWESTERLY RIGHT-OF-WAY LINE OF STATE HIGHWAY 123, INTO AND ACROSS SAID 14.918 ACRE TRACT, THE FOLLOWING COURSES:

SOUTHWESTERLY, ALONG THE ARC OF A CURVE TO THE LEFT HAVING A RADIUS OF 510.00 FEET, A CENTRAL ANGLE OF 23° 20' 26", AN ARC LENGTH OF 207.76 FEET AND A CHORD BEARING S 13° 09' 24" W, A DISTANCE OF 206.32 FEET TO THE SOUTHEASTERLY CORNER HEREOF;

S 87° 44' 35" W, A DISTANCE OF 9.81 FEET TO THE SOUTHWESTERLY CORNER HEREOF;

N 01° 29' 50" W, A DISTANCE OF 3.90 FEET TO THE BEGINNING OF AN ARC OF A CURVE TO THE RIGHT;

NORTHEASTERLY, ALONG THE ARC OF A CURVE TO THE RIGHT HAVING A RADIUS OF 520.00 FEET, A CENTRAL ANGLE OF 22° 21' 16", AN ARC LENGTH OF 202.88 FEET AND A CHORD BEARING N 13° 01' 20" E, A DISTANCE OF 201.60 FEET TO THE POINT OF BEGINNING, CONTAINING 0.048 ACRES (2,072 SQ. FT.) OF LAND MORE OR LESS.


