Presentation and discussion on the Master Thoroughfare Plan - John Foreman, Assistant Director of Planning and Codes

John Foreman introduced Tom Grant with Kimley-Horn. The Thoroughfare Plan contains transportation policy as well as realistic roadway alignments and cross-sections that address the challenges with the current plan.

Chapter 1 provides an overview of the plan and the process used to develop it. Chapter 2 contains the updated map and cross-sections. This will be the most-used chapter day-to-day. As properties subdivide and develop, they will dedicate and develop right-of-way as shown.

Chapter 3 addresses downtown streets, establishing policies that will support a vibrant, walkable downtown and providing detailed design recommendations in order to accomplish this.

Chapter 4 provides guidance on implementing the plan by prioritizing proposed roadways, providing information on funding, identifying potential updates to City codes, and integrating the Bicycle and Pedestrian Plan prepared with the Alamo Area Metropolitan Planning Organization.

The draft has been revised several times as comments have been received from the Task Force, staff, the public, and the Planning and Zoning Commission. The final draft will be updated and presented to City Council at the May 2, 2017 meeting for consideration and approval.
