

## CITY OF SEGUIN

AN ORDINANCE OF THE SEGUIN CITY COUNCIL ESTABLISHING THE LAWFUL SPEED LIMIT ON KINGSBURY STREET (US 90) FROM MILE POST 3.430 NEAR HUMMINGBIRD LAND TO MILE POST 3.938 EAST OF HIGHWAY 123 BYPASS, WITHIN THE CITY OF SEGUIN, TEXAS; DECLARING AN EMERGENCY, PROVIDING FOR PENALTIES; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR AN EFFECTIVE DATE; PROVIDING FOR PUBLICATION OF THIS ORDINANCE; AND AUTHORIZING CITY STAFF TO PREPARE THIS ORDINANCE FOR SUBMISSION AS A SUPPLEMENT TO THE CODE OF ORDINANCES

**WHEREAS,** the Texas Department of Transportation (TxDOT) has conducted a speed study on Kingsbury Street to determine if the current speed limit of 50 mph was proper; and

**WHEREAS,** the study showed that under the current traffic conditions the speed should be reduced in the area from Hummingbird Lane to an area just east of Highway 123 Bypass from 50 mph to 45 mph.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Seguin as follows:

**Part One.** To conform to the Texas Department of Transportation's study, the first two recitals set forth above are hereby adopted, in full, as part of this Ordinance.

**Part TWO.** Section 98-65(b)(1) of the City of Seguin Code of Ordinances is amended as follows (underlining indicates added text, ~~strike through~~ indicates deleted text):

(1) *U.S. Highway 90*, also known as Kingsbury Street, from the west city limits northeasterly and easterly to the east city limits:

- a. From west city limits northeasterly a distance of 1.05 miles .....55
- b. From a point 1.05 miles east of west city limits to Prexy Drive .....50
- c. From Lawson Street to Eighth Street .....45
- d. From Eighth Street to Heideke Street .....35
- e. From Heideke Street to Hummingbird Lane .....~~40~~35
- f. From Hummingbird Lane to mile post 3.938 east city limits line .....~~45~~ 50
- g. From mile post 3.938 to the east city limits line ..... 55
- ~~h.~~ g. MP 20.000 to MP 20.184 .....55
- ~~i.~~ h. MP 22.129 to MP 23.142 .....50
- ~~j.~~ i. MP 1.000 to MP 1.723 .....45

Except that for a distance of 0.283 miles from just east of Governor Ireland Park (MP 1.369) to just west of SH 46 (MP 1.652) the speed limit shall be 30 mph when so signed for school crossing.

**Part Three.** The City's public works manager is hereby authorized to install signage in accordance with this Ordinance.

**Part Four.** Violations of this Ordinance shall be punished in accordance with the penalty provisions of the City of Seguin Code of Ordinances.

**Part. Five.** If any clause or provision of this Ordinance shall be deemed to be unenforceable for any reason, such unenforceable clause or provision shall be severed from the remaining portion of the Ordinance, which shall continue to have full force and effect.

**Part Six.** City staff is authorized to prepare this Ordinance for submission as a supplement to the Seguin Code of Ordinances.

**Part Seven.** In accordance with Section 3.10 of the Seguin City Charter, this Ordinance shall become effective upon ten (10) days following its passage and shall be published in a newspaper of general circulation.
