issues, adding new oversized storm sewer that will be cast in place. This is
waiting design modifications and is expecting delivery from fabricator in about 6
weeks. 2. Pavement design - initial borings were incorrect (not deep enough),
once storm sewer is complete, paving can start. It is estimated to be 6 months
before N. Austin is open to through traffic both ways.
