

CITY OF SEGUIN**ORDINANCE NO.:****STATE OF TEXAS**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS AMENDING THE SEGUIN CODE OF ORDINANCES, APPENDIX C – FEE SCHEDULE, CHAPTER 102, UTILITIES, ARTICLE III, WATER RATES; AND ARTICLE IV, WASTEWATER RATES; PROVIDING FOR A SEVERABILITY CLAUSE; DECLARING AN EFFECTIVE DATE, AND AUTHORIZING CITY STAFF TO SUBMIT THIS ORDINANCE AS A SUPPLEMENT TO THE SEGUIN CODE OF ORDINANCES.

WHEREAS, in preparation for the FY2018 budget the city undertook a study of its water and waste water utilities to develop a five year plan; and

WHEREAS, in a similar manner SSLGC has conducted a study of its needs in order to determine what rates are needed to cover the expenses of producing and delivering ground water to its member cities; and

WHEREAS, the rates proposed by this Ordinance are consistent with the aforementioned studies.

NOW THEREFORE BE IT ORDAINED, by the City Council of Seguin, Texas:

Section 1. Chapter 102, Utilities, Article III, Water, Subsections f, g, and h (rest of section and subsection remain the same) is amended as follows (underlining indicates added text, ~~strikethrough~~ indicates deleted text):

Section 3. In accordance with Section 3.10 of the Seguin City Charter, this Ordinance shall become effective beginning October 1, 2017, said date being at least ten days after publication of this ordinance.

Section 4. If any clause or provision of this Ordinance shall be deemed to be unenforceable for any reason, such unenforceable clause or provision shall be severed from the remaining portions of the Ordinance, which shall continue to have full force and effect.

Section 5. City Staff is hereby authorized to submit this Ordinance as a supplement to the Seguin Code of Ordinances.
