AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS AMENDING THE SEGUIN CODE OF ORDINANCES, APPENDIX C – FEE SCHEDULE, CHAPTERS 2, 18, 22, 66, 74, 90, 102 AND APPENDIX A; PROVIDING FOR A SEVERABILITY CLAUSE; DECLARING AN EFFECTIVE DATE; PROVIDING FOR PUBLICATION, AND AUTHORIZING CITY STAFF TO SUBMIT THIS ORDINANCE AS A SUPPLEMENT TO THE SEGUIN CODE OF ORDINANCES

WHEREAS, as part of the Fiscal Year 2018 budget process staff identified several fees that needed to be adjusted to better reflect actual costs; and

WHEREAS, the proposed fee changes are consistent with the cost of providing the services.

THEREFORE, BE IT ORDAINED by the City Council of Seguin, Texas:

Section 1. With respect to the changes below in Appendix C, Fee Schedule, the only changes to be made are to those sections specifically set forth in the following sections. All other parts of the Fee Schedule, including sections and subsections within the below chapters not specifically set out herein, shall remain unchanged.

<u>a.</u>	Building without a permit – double the fee that would have been charged for a permit if not in downtown historic district – to be paid before inspection or issuance of a certificate of occupancy
<u>b.</u>	Re-inspection fee – Standard re-inspection fee as set forth in this Chapter for buildings and inspections not in the Historic Downtown District
