FIELDNOTE DESCRIPTION

BEING A 0.165 ACRE TRACT OUT OF THE E. GORTARI LEAGUE SURVEY, ABSTRACT 23, LOCATED IN THE CITY OF SEGUIN, GUADALUPE COUNTY, TEXAS, BEING A PORTION OF THAT CERTAIN 1.00 ACRE TRACT CONVEYED TO DANIEL J. SCHACHT AND WIFE, PATRICIA L. SCHACHT BY DEED OF RECORD IN VOLUME 1216, PAGE 298 OF THE OFFICIAL PUBLIC RECORDS OF GUADALUPE COUNTY, TEXAS, SAID 0.165 ACRE TRACT BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING, AT A FOUND ⅓ INCH IRON ROD IN THE SOUTHERLY RIGHT-OF-WAY LINE OF PECAN ORCHARD LANE (AKA DEERSLAYER ROAD - PRIVATE), BEING THE NORTHWESTERLY CORNER OF THAT CERTAIN 5.81 ACRE TRACT CONVEYED TO GUADALUPE PECAN RANCH, INC. BY DEED OF RECORD IN VOLUME 643, PAGE 408 OF THE DEED RECORDS OF GUADALUPE COUNTY, TEXAS, SAME BEING THE NORTHEASTERLY CORNER OF SAID 1.00 ACRE TRACT AND HEREOF;

THENCE, S 72° 42' 10" W, ALONG THE SOUTHERLY RIGHT-OF-WAY LINE OF PECAN ORCHARD LANE, A DISTANCE OF 105.00 FEET TO THE POINT OF BEGINNING OF THE HEREIN DESCRIBED TRACT AND THE NORTHEASTERLY CORNER HEREOF;

THENCE, LEAVING THE SOUTHERLY RIGHT-OF-WAY LINE OF PECAN ORCHARD LANE, INTO AND ACROSS SAID 1.00 ACRE TRACT, THE FOLLOWING COURSES:

S 17° 19' 27" E, A DISTANCE OF 103.92 FEET TO AN ANGLE POINT;

N 72° 42' 10" E, A DISTANCE OF 105.00 FEET TO A POINT IN THE COMMON BOUNDARY LINE OF SAID 5.81 ACRE TRACT AND SAID 1.00 ACRE TRACT;

THENCE, S 17° 19' 27" E, ALONG THE AFOREMENTIONED COMMON BOUNDARY LINE, A DISTANCE OF 30.00 FEET TO THE SOUTHEASTERLY CORNER HEREOF;

THENCE, LEAVING THE WESTERLY LINE OF SAID 5.81 ACRE TRACT, INTO AND ACROSS SAID 1.00 ACRE TRACT, THE FOLLOWING COURSES:

S 72° 42′ 10″ W, A DISTANCE OF 135.00 FEET TO THE SOUTHWESTERLY CORNER HEREOF;

N 17° 19′ 27″ W, A DISTANCE OF 133.92 FEET TO A POINT IN THE SOUTHERLY RIGHT-OF-WAY LINE OF PECAN ORCHARD LANE, FOR THE NORTHWESTERLY CORNER HEREOF, FROM WHICH A FOUND $\frac{1}{2}$ INCH IRON ROD BEARS S 72° 42′ 10″ W, A DISTANCE OF 69.01 FEET;

THENCE, N 72° 42' 10" E, ALONG THE SOUTHERLY RIGHT-OF-WAY LINE OF PECAN ORCHARD LANE, A DISTANCE OF 30.00 FEET TO THE POINT OF BEGINNING, CONTAINING AN AREA OF 0.165 ACRES OF LAND, MORE OR LESS.
