Presentation and discussion concerning the regulation of group homes - Andy Quittner, City Attorney

City Attorney Andy Quittner stated that this discussion is due to the City receiving complaints about a recently open recovery house called Oxford House. The Oxford House is a self-run, self-supported recovery house located within Elmwood Subdivision. Federal law has taken away any regulations from the City. Fair Housing Act & ADA Act cover these homes, 6 victims and 2 caretakers allowed. The idea is that these homes become more integrated into a community, half-way houses are under a different set of regulations.

Federal guidelines is not as strict and we would have to go to court and fight it out. Dept of Aging & Disability, Medicad, for level of care. If you are going to a Federal agency you must have actual proof. Cars - they may not keep more cars than the number of residents in the home.

According to Oxford House website, it is a national non-profit organization with a concept in recovery from drug and alcohol addiction, that was founded in 1975. Oxford House has increased the number of houses for mental health issues. Oxford House has a habit of coming into a community, remodeling, licensed by the state, cannot have 2 homes within 1/2 mile. Mr. Wynn pulled the police calls for the entire neighborhood and there have been only two calls for loud music, but for Montclair there have been nine calls, seven specific to that house. Oxford House does advocate in prisons. What triggers to call this house a nuisance?

The neighborhood is zoned residential. Two men working at the house for weeks. The website says that the Seguin Recovery facility will house women and No live in supervision. There were 3 women but now only 2 since relapsed. They planned on 12 people with 2 to each room. Concerned about the welfare of children within the neighborhood. People bought homes in this area because it is quite and safe. There

has to be regulations to help homeowners.

Mayor Keil said tonight is an informational meeting and the City Attorney will determine who is the regulating authority and where we report issues to. Parking may be a problem. If it is a state registered home you contact the state. Planning & Zoning will continue to monitor the location and will continue to be vigilant.
