Resolution authorizing a pause on accepting filing of all development plats and other documents in the City of Seguin under Local Government Code Chapter 212, Subsection A, beginning August 9, 2019 and continuing through September 30, 2019 - Pamela Centeno, Director of Planning & Codes and Andy Quittner, City Attorney

The new State law requires that the Planning Commission approve or disapprove a plat within 30 days of filing. If this is not done, then the plat is automatically approved and the City must sign the plat, no matter how poorly it was developed. If not approved, then the disapproval must be specific and complete with cites to the law and ordinances not met. The disapproval is a one shot affair, if something is missed, you can't pick it up on subsequent reviews. The developer then must address the reasons for disapproval and resubmit to the City. When this is done the City has 15 days to have the Planning Commission approve or disapprove the submittal. The new laws passed also specifically prohibit a city from requesting a waiver of the time period. Absent a larger staff and a Planning Commission that meets twice a month, and considering the recent influx of plat applications submitted, this process is unworkable. Staff is recommending a temporary pause on the acceptance of plat applications and the required accompanying development documents while the amendments to the City's regulations are drafted. The pause would be effective August 9, 2019 through September 30, 2019.

As everyone knows she operates a Bingo Hall in Geronimo but she wanted to help City Council understand why the law was changed on the taxes collected on the bingo prize payout. Taxes on the winnings must be collected, currently 5%, with 2 1/2% going to the State and the other 2 1/2% being distributed to the city and county. The new law was written to allow the charity to keep the 2 1/2% rather than the operator to submit the funds to the city and/or county. The State will no longer collect and distribute the funds to the city or county.

Several council members questioned what if the establishment did not pay their taxes then it becomes the City's responsibility to collect? Yes, just as Hotel Occupancy Taxes.

		City Manager Doug Faseler and Director of Finance Susan Caddell presented the proposed FY2020 Budgets. Some highlights include:
		The FY2020 expenditures increased \$485,792 or 1.6% when compared to FY2019. Costs for personnel and benefits represent 70% of the total General Fund expenditures.
		FY2020 General Fund Expenditures
		 (1) Salaries and Benefits - \$802,144 includes a 2% COLA effective January 1, 2020. (2) Transfers to General I&S Fund - \$300,538 due to the reduction of the I&S contribution from the CPS Funds (3) Indigent Health Care (This represents a 5% increase) - Estimate of \$87,237
		Personnel:
		Police Department - An Evidence and Forensic Specialist (\$64,288) is proposed. If the new position is approved, the current Evidence and Forensic Specialist is proposed to be upgraded to Evidence and Forensic Specialist Supervisor (\$4,945).
		DARE position is reclassified to Elementary School Coordinator, a civilian position. It will be funded from the DARE funds. The savings from this reclassification will assist in being able to fund a new Police Officer - Detective position (\$77,558) to help address the departments increasing case load.
		Animal Services Officer - position is proposed to be upgraded to an Assistant Supervisor (\$3,539).
		Library - proposing an additional Library Assistant (\$46,683).
		Parks - proposing an additional Landscape Technician (\$43,431).
		Main Street & Convention and Visitors Bureau - proposing to upgrade the Administrative position to Assistant Director (\$32,972).

Golf - proposing a part-time Pro Shop Assistant (\$3,591) and part-time starters (\$20,000). Due to the Pro Shop temporarily moving to the Parks building while under renovations.

Public Works Vehicle Maintenance - proposing to add an Auto Technician II (\$53,300). Split between General and Utility Fund.

Planning Department - an additional Code Compliance Officer (\$58,981) is proposed. In addition, an Administrative Technician (\$46,674) is being proposed.

Brush Division - proposing to upgrade one Equipment Operator I to Equipment Operator II (\$3,800).

Information Technology - proposing an IT Intern (\$7,810). Funding will be split between the General and Utility Fund.

Capital Projects/Engineering - proposing an Engineering Technician/Graduate Engineer (\$80,673). *Split between General and Utility Fund.*

Fire/EMS - FEMA SAFER grant paid for 75% for two years for three firefighter/paramedic positions. Beginning in February 2020, the grant contribution will lower to 35%, resulting in the City's match to increase from 25% to 65% (\$104,695).

FY2020 Utility Revenue Fund

The projected FY2020 revenues show an increase of \$2,529,906 when compared to FY2019, a 5% increase. The projected electric revenues are expected to increase by \$653,522, with a slight increase in consumption expected. The projected water revenues are expected to increase by \$828,850 based upon the approved rate adjustments from the updated water rate study and the increase in consumption with the new developments. Sewer revenues are projected to increase by \$813,853 based upon the approved rate adjustments from the updated water rate study and the increase by \$813,853 based upon the approved rate adjustments from the updated wastewater rate study for FY2020 and an increase in the number of customers and increase in water consumption.

Expenditures:

(1) Salaries and benefits - \$715,116 includes a 2% cost of living increase effective in January 2020.

(2) Indirect Cost Allocation - \$600,000 based upon proposed FY20 General Fund budget and an increase in the percentage allocation.

(3) Transfers to Utility Fund Capital Projects - \$169,658 (additional projects being funded)

(4) ROW User Fees - \$158,917 due to an increase in electric, water, and sewer revenue

Personnel:

Utility Services - proposing a Utility Line Locator/Inspector (\$59,698).

Facilities - two Service Workers (\$83,917), part-time Service Worker & a pool of temporary Service Workers (\$17,907) being proposed.

Economic Development - the addition of an Assistant Director of Economic Development (\$88,977). Half of this position is being provided by Seguin Economic Development Corporation.

The Emergency Fund, Capital Improvement Projects, Capital Equipment, and Street/Highway/Drainage Projects were outlined for FY2020.

Tax Rate:

The Effective Tax Rate is \$.5351 which is \$.0061 above the current tax rate of \$.5412. Recommend maintaining the current rate.
