Governor Mandated Adjustments- Hospitalizations vs Hospital Capacity



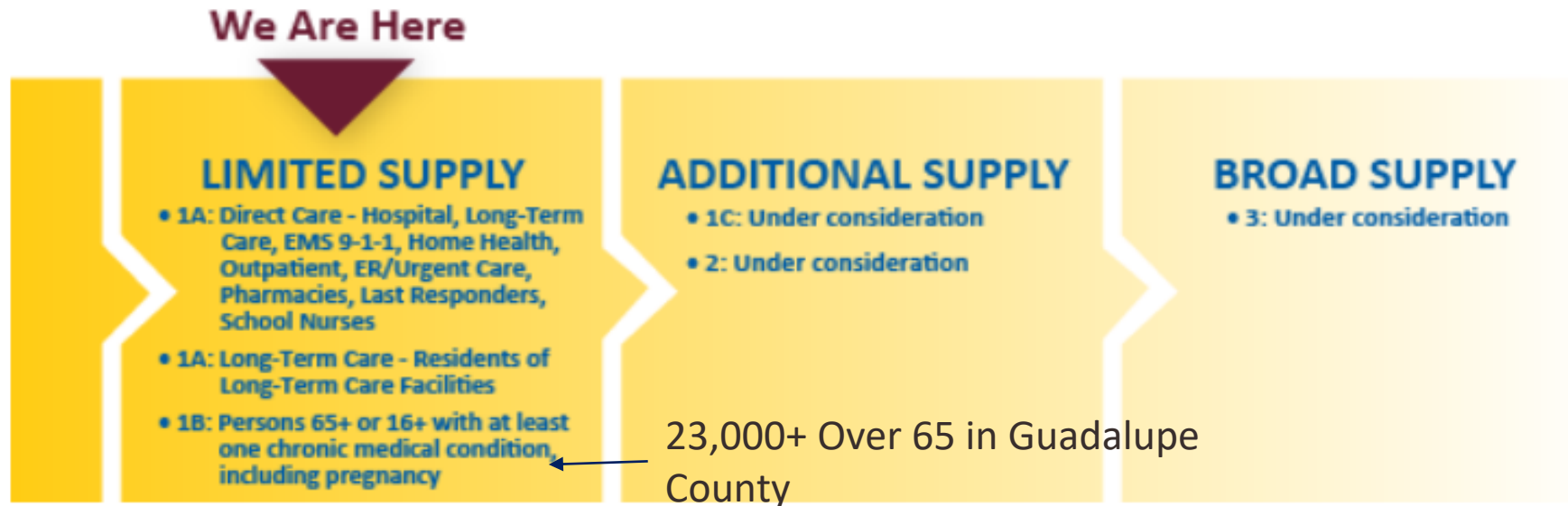

MASS COVID VACCINATION PLAN

- **This will take months to complete**
- **More complicated than you might think (Issues related to vaccine storage, processing, staging, administration etc.)**
- **Will work with the County, GRMC and local health providers on mass distribution plan**
- **Some of this is out of City/County Control**

Hospital Update through 01/05/21

- 37 people currently hospitalized at GRMC
- 14 in critical care

- 7 day rolling avg for new daily admits- 5-6 patients
- 7 day rolling avg for Covid patients- 33 patients
