AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS AMENDING THE UNIFIED DEVELOPMENT CODE (UDC), SECTION 3.4.3 – LAND USE MATRIX, AMENDING THE LAND USE FOR RV PARKS; PROVIDING A SEVERABILITY CLAUSE; AUTHORIZING CITY STAFF TO PREPARE THIS ORDINANCE FOR SUBMISSION AS A SUPPLEMENT TO THE CODE OF ORDINANCES; PROVIDING FOR PUBLICATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Seguin City Council adopted the Unified Development Code (UDC) to encourage better planning and development throughout the city and established in the UDC a list of allowed land uses for the adopted zoning districts; and

WHEREAS, the UDC only allows the use of a RV Park in the Commercial zoning district with a Specific Use Permit in the land use matrix; and

WHEREAS, City staff finds that a RV Park in the Manufactured-Residential (M-R) zoning district requiring a Specific Use Permit would allow the opportunity for adjacent property owners to voice any concerns or identify any impacts on neighboring properties; and

WHEREAS, on January 12, 2021, after conducting a public hearing, the Planning and Zoning Commission voted to recommend to City Council that the amendment to the UDC regarding the use of a RV Park in the Manufactured-Residential (M-R) zoning district within the Overnight Accommodations section as described herein be adopted.

NOW THEREFORE BE IT ORDAINED by the City Council of the City of Seguin, Texas, as follows:

PART ONE. Section 3.4.3- Land Use Matrix: Overnight Accommodations, of the Seguin Unified Development Code is hereby amended as follows (<u>underlining</u> indicates added text, strikethrough indicates deleted text):
