AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SEGUIN, TEXAS AMENDING THE SEGUIN CODE OF ORDINANCES, APPENDIX C – FEE SCHEDULE, CHAPTER 66, LIBRARY TO ADD FEES RELATED TO TABLETS AND MOBILE HOT SPOTS; PROVIDING FOR A SEVERABILITY CLAUSE; DECLARING AN EFFECTIVE DATE, AND AUTHORIZING CITY STAFF TO SUBMIT THIS ORDINANCE AS A SUPPLEMENT TO THE SEGUIN CODE OF ORDINANCES

WHEREAS, the library is launching two new services this month that necessitate the adding of fees to cover expenses and potential loss of equipment; and

WHEREAS, the proposed fee changes are consistent with the cost of providing the services.

THEREFORE, BE IT ORDAINED by the City Council of Seguin, Texas:

Section 1. With respect to the changes below in Appendix C, Fee Schedule, the only changes to be made are to those sections specifically set forth in the following sections. All other parts of the Fee Schedule, including sections and subsections within the below chapters not specifically set out herein, shall remain unchanged.

SECTION 2. Appendix C – Fee Schedule, Chapter 66, Library, of the Seguin Code of Ordinances is amended (all sections not appearing below remain unchanged) as follows (<u>underlining</u> indicates added text, <u>strikethrough</u> indicates deleted text):
