AN ORDINANCE OF THE CITY COUNCIL OF SEGUIN, TEXAS AUTHORIZING THE ABANDONMENT OF THE CITY'S INTEREST IN THE UNIMPROVED STREET RIGHT-OF-WAY FOR LAVACA LANE DEDICATED AS PART OF PARKVIEW ESTATES, CATER'S ADDITION; ASSIGNING ABANDONED RIGHT OF WAY TO ADJOINING PROPERTY OWNERS; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL NECESSARY DOCUMENTS

WHEREAS, before annexation into the City, Lavaca Lane was dedicated as street right-of-way by the original plat of Parkview Estates; and

WHEREAS, to date Lavaca Lane, which runs between Guadalupe River Drive and Rio Grande Drive, has not been improved for use as a street or alley way; and

WHEREAS, in 1998, an amended plat was recorded for what is known as the Cater's Addition to Parkview Estates that changed a few of the lots and noted that Lavaca Lane was undeveloped; and

WHEREAS, in 2000 some of the residents adjoining Lavaca Lane filed a Boundary Line Agreement (Volume 1542, Page 209) reassigning property areas, including some of Lavaca Lane; and

WHEREAS, the owner of Lot 127, one of the four lots adjoining Lavaca Lane, needs to replace an existing septic system that includes a drain field that encroaches into the Lavaca Lane right-of-way; and

WHEREAS, after discussion with city departments it is clear that the City has no proposed use for the street right-of-way; and

WHEREAS, city staff recommends that the right-of-way to Lavaca Lane be abandoned in favor of the adjoining landowners subject to the terms of their previously filed Boundary Line Agreement.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Seguin

SECTION ONE. The City Council hereby approves and authorizes the abandonment of Lavaca Lane running between Guadalupe River Drive and Rio Grande Drive.

SECTION TWO. The abandoned right-of-way shall be divided among the adjoining property owners in accordance with the previously filed Boundary Line Agreement attached to this Ordinance; with any remaining property to be divided equally between the adjoining property owners.

SECTION THREE. The City Manager is authorized to execute any documents, including quit claim deeds, necessary to carry out the right-of-way abandonment.
