Jeff Billows, Chief Operating Officer for State Highway 130 gave, and update to City Council regarding the growth within Guadalupe County. Mr. Billow shared a power point presentation with some information about the SH 130 Concession Company. The following information is what was on presentation slides.

* Operates and maintains southern 41 miles of State Hwy 130 between Seguin and Mustang Ridge *Road opened in 2012 and company came under new ownership in 2017.* 100M invested in last 5 years to improve ride quality and enhance safety * Has approximately 35 full-time employees *24/7 traffic management center and road side assistance. Traffic on SH 130 continues to increase *Traffic jumped 17% in 2022 *

Roadway is congestion-free and still has plenty of capacity. **Region is experiencing unprecedented growth** Guadalupe County added over 41,000 residents from 2010-2020k, a 31% increase in population *Over 50 subdivisions and nearly 15,000 dwelling units are currently in the development pipeline in Seguin alone * The County is expected to surpass 300,000 residents just after 2045, with population growth of almost 70% by 2050. ** Congestion and commute times up across the area*Mean commute times for -Guadalupe County residents increased 11.2% between 2021 during a period of less commuter activity * A recent survey, 85% of respondents in Guadalupe and Comal Counties said traffic has become worse over the last 5 years. **Proposed non-tolled connector road between I-35 and SH130** High-speed, non-tolled connector highway between I-35 and SH 130 would improve east-west mobility and reduce congestion * Route and alignment will be led by local municipalities in partnership with TxDOT and other stakeholders; SH130 Concession Co. does not have eminent domain authority. * SH 130 prepared to fund and expedite project through contract changes with the State* A connector provide fast east-west access for local and regional residents, improved response times, and high-speed alternative route to I-10*The is an opportunity to deliver a much-needed piece of transportation infrastructure at no cost to the county or city

Yesenia Rizo, 1004 E Weinert St., Seguin, Tx 78155; Ms. Rizo is the property owner of 772 Johnson Ave. Ms. Rizo stated she was aware of the concerns of the property owners surrounding the property at 772 Johnson, stating that any noise or maintenance issues would be the same whether it was one residential or two. Ms. Rizo stated that she is diligent, and responsible when it comes to the quality of the building structure and aesthetics. Stating that she feels the new build will upgrade the neighborhood and will encourage neighbors to keep their own properties looking good and making upgrades as well. Ms. Rizo states that she checks on all her properties regularly to make sure they are all in proper order.

Javier Cuevas, 2990 Palomino Pass, Seguin, Tx 78155; Mr. Cuevas spoke on how he and several others in the area are opposed to the idea of having a duplex in this neighborhood. Also stating that if the zoning were to be changed then other lot owners in the area may decide to do the same.

Mayor Donna Dodgen stated it was not a super majority so the request has been denied, upholding P&Z recommendations.

City Attorney Sam Aguirre states the motion to approve has failed and there should be another motion.
