Consideration of plans for the development services center - Rick Cortes, Assistant City Manager

Rick Cortes explained the work that is being proposed for the new Development Center located at 108 E. Mountain Street. He introduced Tim Gescheidle with TSG Architects who presented the conceptional plans for the Development Center. The new center will have 10 offices, two conference rooms, a lobby. The overall design allows for future growth. It is estimated that the project will cost \$2.9 million and will be complete by December 2018.

Council Members Mathis and Herbold stated they were not comfortable with the price. Research shows that it should cost between \$150-\$160 a square foot. After discussion, Council Members agreed they are comfortable with the conceptional layout but not the overall cost. There are areas that need to be reviewed and expenses cut, such as roof, IT, furniture, exterior renovations.
