Council Member Jim Lievens said "we are public servants and it's important that we listen to the will of the people." He continued stating "we as public servants ask for and more importantly we listen to citizen input and while we may not always be in a position where we can change a decision, this is not the case.

Council Member Mark Herbold explained the council's original vote did not focus on the Matador or It's Real logo, Council's concern was with getting the project completed for the right cost.

The following individuals spoke on keeping the Seguin Matador theme as it is today and the pride it shows in the schools and community. Encouraged the City Council to reconsider their decision.

Assistant City Manager Rick Cortes advised that while the city did have a cost within the bid for a logo, the cost will not cover the cost of the Seguin Matador theme as it is today. The additional cost is \$14,000.00 and should be covered by the Seguin ISD or Booster Clubs. Staff has surveyed the surrounding communities and it is the policy that the schools or organizations pay for the logo.

Cathy Beicker, Seguin Booster Club President, said that they were not aware that the tank would need to be repainted as well as the logo every fifteen - twenty years. Ms. Beicker asked if the motion could be amended to split the cost between the two (city & booster clubs). Mayor Keil agreed but asked that the decision of the artwork be decided no later than 60 days and asked that the motion reflect.

Council Member Lievens made an amended motion to keep the artwork on the Lucille Water Tower Matador themed, allow the Seguin ISD input within a 60-day timeframe, and split the cost not to exceed \$14,000.00 between the City of Seguin and Seguin Boosters. Council Member Mathis seconded the motion that this Action Item be approved. The motion carried by the following vote:
