Mrs. Pastrano spoke about the lack of drainage and that water just sits in her front yard at the corner of High Point Drive and Friesenhahn Road. Mayor Don Keil said that staff will investigate the complaint.

Council Member Chris Aviles addressed the City Council on drainage issues. Some areas named were Friesenhahn Road, 1000 Block of Fleming Street, Hildalgo Street, and Volunteer Street. Council Member Aviles had prepared a handout of areas that need to addressed and asks that City Council consider a resolution to address this issue.

City Manager introduced the new Public Information Officer, Jennifer Sourdellia and the Interim Police Chief Russell Pancoast.

Mayor Don Keil recognized Parks & Recreation staff for the Holiday Stroll parade as it was an amazing event. The city's Holiday Stroll Parade is getting bigger each year. Also, recognizing Main Street and CVB for their work on the Downtown Events during the Holiday Stroll weekend.

6. Presentation

Update on Business 123 Hwy (Austin Street) Reconstruction Project - Will Lockett, TxDOT Area Engineer

Will Lockett, TxDOT Area Engineer stated that North Austin Street is open for two-way traffic since the 15th. Mr. Lockett provided a brief update of the North Austin Street road construction on what still needs to be completed. From Martindale Street to the railroad tracks, curbs, sidewalks and the final riding surface will have to be added while the remaining section from Martindale Street to IH-10 will start. Side streets along Austin Street will remain closed until the concrete driveways are done and tied in. The project plans to be completed by June 2019.

Lockett also provided details on the project between IH-10 and SH 46. A separate contractor will be performing the horizontal pavement signage to clarify directions to SH 46 or FM 78. City Manager Doug Faseler stated that residents have commented on how confusing it is without markers/signs.

The regular meeting was recessed and the public hearing was called to order. Jake Brown with LDG Multifamily LLC spoke on behalf of the proposed low-income housing, stating that this was just a formality that the Federal Government required. The public hearing was adjourned and the regular meeting was reconvened.

Mayor Keil stated that he was opposed to the proposed development as the City of Seguin does not need public housing and especially at this location across from Texas Lutheran University. After discussion the City Council was in agreement that additional information is needed. For instance, a market study, work with Seguin Housing Authority to determine a needs assessment, talk with Texas Lutheran University, traffic study through Texas Department of Transportation as Court Street is a main throughofare.
