Councilmember Fonda Mathis said if adopted she wanted the estimated \$150,000 added to FY2020 Street Maintenance Budget. City Manager Doug Faseler & Susan Caddell, Director of Finance, advised that the estimate was already embedded in the budget. If the Council should vote no on this ordinance then we would need to look at other funds to decrease to make up the difference. Assistant City Manager Rick Cortes said that as the city continues to grow with the new developments this dollar amount will grow each year.

Mayor Keil stated that this would provide a dedicated revenue source to repair streets each year.
