Jason Biesenbach announced his intention to seek the Seguin City Council District 7 position. Mr. Biesenbach provided a brief background.

Paul Martin spoke on economics as we grow and the climate changes and air pollution.

Gary Vaughan 503 South Goodrich Seguin, Texas

Gary Vaughan stated that his mother, Ruby Vaughan, was the 1949 City Women's Golf Championship. He was the 4 time winner of the Men's Golf Championship during the 1970's. Mr. Vaughan stated we need a Organic Junior golf program. In 1969 the City declared one week as "City Golf Week." Do not run the golf course as another utility. He suggested an Analysis Committee be put together to determine if we have the right personnel in the right position to operate the golf course.

Paul Gaytan 215 West Nolte St Seguin, Texas

Paul Gaytan announced his intention to seek the Seguin City Council District 5 position. Spoke on his background/career.

Council Member Jeremy Roy said he is excited about Paul Gaytan seeking Council District 5 and he fully supports Mr. Gaytan. He said it has been a pleasure serving District 5 constituents and working with the Council Members these past 4 years.

City Manager Steve Parker also wanted to recognize all the Fire Departments that assisted Seguin with a serious fire and thankful they were able to limit the fire to the one structure.

b. 22-323 Update on the Golf Course Capital Projects - Bruce Allen, Golf Course Manager

Indexes:

Golf Manager Bruce Allen introduced Greg Gallup, the new Golf Assistant who begins work on August 8, 2022.

Bruce Allen stated that in January 2022 \$1,500,000 of ARPA funds were approved for renovation of the Golf Course irrigation system. National Golf Foundation was contracted to conduct a study of our operational and capital needs at Starcke Park Golf Course. Mr. Ed Getherall led the study and provided a presentation on the data

collected. Provided the recent facility performance and the market demographic & economic factors.

Jeff Brauer and Brian Ross assessed design/routing; conditions, and safety. Typical life-cycle of golf course components is 20 to 30 years; Max Starcke Golf Course is well past this on all infrastructure. Course conditions are poor; Greens get a combination of high play, low maintenance budgets, older equipment, and presence of 7-8 mutations of grass has led to poor putting surfaces. Tees are undersized and un-level. Driving Range has insufficient teeing area and safety issues; Irrigation System and Bunkers are obsolete. Reached an inflection point and needs major overhaul to remain a viable golf course.

Rebuild/Replace major infrastructure components, including greens, green surrounds, tees, bunkers, irrigation system

Improve and enlarge driving range landing area and teeing area; mitigates safety issues

Add short game practice area

Re-route and enhances design features - Hole #'s 10, 14, 17, 18

Enlarge #18 irrigation lake

Pecan tree mitigation

Preliminary Cost Estimate is \$7.6 million

Renovation Option 2 (Recommended Plan if funding constraints)

Rebuild/Replace major infrastructure

Driving range work to tee area, nets, range machine only

No re-routing/design work to add interest and enhance safety

#18 lake dredged and possibly enlarged

Less tree mitigation

Preliminary Cost Estimate is \$5.85 million

(Does not include operating losses during construction year - estimated at \$850K for one-year/\$1.3 million for two-year projects)

City Manager Steve Parker said \$6 million would be a one-year renovation project with the \$1.5 million to begin with a architectural design. I think Option 2 is more what we were looking at. The remainder issued debt would be \$4.5 million. We can look at mitigating operational expenses and other areas, which would save money.

City Manager Steve Parker and Director of Finance Susan Caddell presented the proposed FY2023 Budget. This budget will raise more revenue from property taxes than last year's budget by an amount of \$2,093,914, which is a 16.10 percent increase from last year's budget. The property tax revenue to be raised from new property added to the tax roll this year is \$971,028. The City's certified net taxable value has increased from \$2,809,272 to a taxable value of \$3,180,481,715. This is a \$371,213,443 or 13.2% increase. The average taxable of a home has increased from \$192,334 in FY22 to \$216,975 in FY23. This year's no new revenue tax rate is \$.4774, which is \$.0638 below the current tax rate of \$.5412. This rate is below our current rate due to the fact in FY2, we had a large increase in new property and new improvements. Last fiscal year, these values were not included in the calculation of the no new revenues rate calculation. This fiscal year, they are included in the calculation. As of the date of certification, there was still \$308,962,401 of taxable property under protest. After six years of maintaining the same tax rate, staff is proposing to decrease the tax rate to \$.5225. This increase above the no new revenue rate would bring an additional \$1.2 million. This increase would fund a larger cost of living increase for employees as well as additional police officers and other much needed positions. It would also begin the establishment of a Building/Infrastructure Fund. Due to the fact this rate is above the no new revenue tax rate, there is a requirement for a tax rate public hearing and additional tax rate legal notices.

Mr. Parker said we are recommending a 5% cost of living for all employees beginning in January 2023 and reviewed the proposed additional personnel for the Capital Projects and Engineering, Finance Department, Fire Department, Parks & Recreation, Planning & Codes, Telecommunications, Public Works, Golf Course, some position upgrades, and certification pay. He also reviewed the Capital Improvement Projects and Capital Equipment for the General and Utility Fund.

Mr. Parker and City Council did discuss possible increase in Elected Officials compensation. Susan Caddell said that there has only been one adjustment to the

salaries in the past 33 years that she is aware of. Mr. Parker will make some inquiries and bring something back for Council to consider.
